The list of register numbers of candidates those who have been provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the post of **District Educational Officer in the Tamil Nadu School Educational Service (2012),** based on the results of the Main Written Examination conducted by the Commission on 06.08.2015 FN, 07.08.2015 FN & 08.08.2015 FN was published on 10.11.2016.

Due to non-availability of candidates from among Teachers employed in recognized Aided Secondary or Higher Secondary schools against the vacancies in Physics and Chemistry subjects, it has been decided by the Commission, to provisionally admit the candidates for Certificate Verification based on the written examination marks and their claim in the online applications with regard to teaching experience after acquiring B.T or B.Ed qualification [except the candidates those who have already attended Certificate Verification for Oral Test in Phase-I held on 21.11.2016] so as to verify their eligibility for admission to Oral Test under the Teacher Category in Physics and Chemistry subjects. Hence, apart from the candidates who had already completed the certificate verification, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for the said post. ## Notes:

- 1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.
- 2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification based on the marks obtained by them in the Main Written Examination, Educational Qualification, Experience possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Experience, Community, etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled.
- 3. The Candidates who have appeared for the Main Written Examination and whose register numbers are not found in the above list have not been admitted to the Certificate Verification for Oral Test.
- 4. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras/ Madurai Bench of Madras High Court in the W.P.Nos.22160, 22161 & 40776/2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in cancellation of their provisional admission to Certificate Verification.
